Clearflex RM 50 U is a linear medium density polyethylene resin, with antioxidants and UV stabilizers, suitable for rotomoulding applications.

Items manufactured with Clearflex RM 50 U show good mechanical properties and high environmental stress cracking resistance (ESCR).

Main Application

Thanks to good balance between mechanical properties and processability, Clearflex RM 50 U is recommended for the production of medium capacity containers and hardly shaped items.

Processing notes

Clearflex RM 50 U can be processed by rotomoulding technology using all machinery types. This material, when properly converted, allows obtaining finished items having good surface. Suggested temperature range to obtain such results is from 230 °C to 280 °C, depending on the residence time in the mould.

Storage and Handling

Clearflex RM 50 U is supplied in pellet form. This material may readily be conveyed and bulk fed through equipment designed for conventional pelletised polyethylene resin, provided the equipment is designed to prevent accumulation of the fines and dust particles that are contained in all polyethylene resins. These fines and dust particles can, under certain conditions, pose an explosion hazard. We recommend that the conveying system used be equipped with filters of adequate size, operated and maintained in such a manner to ensure that no leaks develop and earthed adequately. We further recommend that good housekeeping should be practised throughout your facility.

The product should be stored in dry conditions at temperatures below 50 °C and protected from sunlight. Improper storage can initiate degradation which results in odour generation, colour changes and can have negative effects on the physical properties of the product.
